- (1) Option vests with respect to 1/48th of the shares subject thereto monthly commencing on December 14, 2009, such that the option will be fully vested and exercisable on December 14, 2013.
- (2) Reflects a 2-for-3 reverse stock split of the Issuer's outstanding securities effected immediately prior to the effectiveness of the Issuer's S-1 Registration Statement (Commission File No. 333-164044).

100% of the shares subject to the option are immediately exercisable. However, all unvested shares of common stock underlying the option are subject to a right of (3) repurchase held by the Issuer, which right of repurchase will lapse as the shares vest according to the following schedule: 25% of the shares subject thereto vest on December 14, 2010, with 1/48th of the shares vesting monthly thereafter, such that the option will be fully vested on December 14, 2013.
